Sub:- Release of Tier-I marks for the post of Senior Personal Assistant & Personal Assistant (post code 801/24) in District and Sessions Courts/Family Courts and shortlisting for candidates for Tier-II i.e. Descriptive Test (English Language).

1. The DSSSB vide its vacancy notice/ Advertisement No. 01/24 dated 12/01/2024 with closing date 08/02/2024 had advertised 424 vacancies {UR-66, EWS-65, OBC-162, SC-80, & ST-51 including PwBD Category (C)-30} for the Post of Senior Personal Assistant & Personal Assistant under post code 801/24 in District and Sessions Courts/Family Courts.
2. The normalized marks obtained by 11179 candidates who appeared in written examination held on 08/03/2024, 17/03/2024, 23/03/2024 & 31/03/2024 has been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dssbsonline.nic.in.
3. Based on the performance in Tier-I written examination (online mode), out of these 11179 candidates, Total **5059 candidates** {UR-1657(Including EWS-177, OBC-259, SC-157, ST-19), EWS-478(Including PwBD-01), OBC-1071(Including PwBD-04), SC-1562(Including PwBD-08), ST-272, PwBD Category(C) - 19} have been provisionally shortlisted for Tier-II i.e Descriptive Test (English Language) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms:

4. The shortlisted candidates shall be called for Tier-II i.e. Descriptive Test (English Language) separately.
5. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II examination does not entitle them any right over the post.
6. As per the examination scheme, the Tier-I (MCQ) exam shall be taken for shortlisting candidates only for Tier-II Exam. The number of candidates to be called for descriptive examination shall not be more than 25 times of the vacancies advertised. Minimum qualifying marks Tier-I (MCQs) is 50% for General Category and 45% for Reserved Category.
7. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
